
## Let's stop truancy together!



## Together our community can limit truancy

## **Objectives**

- Improve attendance
  - Share resources
- Community outreach

Students who don't attend school regularly are more likely to:

- Drop out, which over their lifetime will cost the nation approximately \$800,000 per drop out, in lost earnings and forgone taxes
- Engage in delinquent behavior in the community during the time in which they should be in school
- Experience family dysfunction
- · Engage in substance abuse
- · Struggle with social isolation
- May have an unwanted pregnancy
- Experience unemployment

For your information:

When a student is absent, parents must send in a note upon the student's return to school. Failure to provide a note means the absence may be marked unexcused/illegal. After several unexcused/illegal absences, there are interventions that can be done through a partnership between the schools, parents, and students. Even when the absence has a note, as the number of absences continue, the school will require a doctor's excuse for all subsequent absences as a way to combat truancy. Some people may try to avoid truancy issues by getting doctor's excuses for children who continue to miss school, even though the child isn't really sick. Because of this, schools are not able to address truancy because the absences are "excused", however, it is usually best to let the system work as the conversations with the team can help get services for children that may not ever get addressed through avoidance.

"Regular school attendance is a law in PA. Anything over 10 absences is considered excessive."

Ways you can help:

- Refrain from writing excuses for students who are not physically seen in your office
- Be sure to include a date on excuses when students are expected to be medically able to return to school
- Contact school officials if you are concerned that a student is experiencing excessive needs for excuses yet doesn't display symptoms necessary to miss school
- · Avoid back dating excuse cards
- Contact the child's school with any concerns
- Report any suspected abuses to the child's school
